- (1) Mr. Kennedy did not sell any of the 10,438 reported shares. Rather, this amount represents shares withheld pursuant to the terms of a shareholder-approved stock plan for the payment of withholding taxes due upon the 1/10/12 vesting of 28,084 of the 84,250 shares of restricted stock Mr. Kennedy was granted on 12/8/08. These withheld shares are not sold on the open market and become Revlon, Inc. treasury shares.
- (2) Of these 111,550 shares reflected as beneficially owned, 20,000 shares are shares held in the reporting person's account under the Revlon Employees' Savings, Investment and Profit Sharing Plan.
