The reporting person will provide, upon request by the SEC staff, the Issuer or a security holder of the Issuer, full information regarding the number of shares purchased at each separate price within the range.

(3) Represents the sale of shares in [ 240 ] separate transactions, ranging in price from \$13.62 to \$13.74, resulting in a weighted average sale price per share of \$13.66. The reporting person will provide, upon request by the SEC staff, the Issuer or a security holder of the Issuer, full information regarding the number of shares purchased at each separate price within the range.
