(1) For 2016, the reporting person agreed to take 100% of her cash bonus in the form of shares of restricted stock with an eight-year restriction period. Because the reporting person elected to take her bonus for 2016 in shares of restricted stock, the Company awarded the reporting person additional compensation, in restricted stock, equal to her cash bonus.
