### Remarks:

On June 30, 2006, pursuant to a written agreement dated May 15, 2006 between Crestview Capital Master, LLC ("Crestview") the Issuer, (i) Crestview exercised, on a cashless basis, 1,010,000 Warrants and received 1,010,000 shares of Common Stock and (ii) as consideration for such cashless exercise, the Issuer cancelled 1,010,000 Warrants owned by Crestview. There was no consideration paid by Crestview to the Company in connection with these transactions.

Since Crestview had previously waived the beneficial ownership limitations on exercise in the Warrants, as further described on Schedule 13D (Amendment No. 2) filed on July 24, 2006 with the Securities and Exchange Commission, the result of the transactions described herein was to lower Crestview's beneficial ownership of Common Stock from 7,568,759 shares to 6,558,759 shares.

Crestview is the beneficial owner of 6,558,759 shares of Common Stock, which, to Crestview's knowledge, represents

approximately 24.54% of the outstanding Common Stock as of the date hereof (based upon 26,723,244 issued and outstanding shares of Common Stock as of June 30, 2006, as reported in writing to the Reporting Persons by the Chief Legal Officer of the Issuer on July 18, 2006).
