Amendment of Voting Proxy Agreement with Phyllis G. Redstone

On October 18, 2006, WMS Industries Inc. (the “Corporation”) entered into an amendment (the “Amendment”) to that certain voting proxy agreement (the “Voting Proxy Agreement”), dated November 8, 2002, by and between the Corporation, Ms. Phyllis G. Redstone and Mr. Neil Nicasro, relating to any and all shares of common stock of WMS Industries Inc. owned by Ms. Redstone in favor of Mr. Neil Nicasro. Pursuant to the Amendment, Mr. Brian R. Gamache, President, Chief Executive Officer and a member of the Board of Directors of the Corporation, will replace Mr. Nicasro as proxy holder under the Voting Proxy Agreement.
