The following constitutes Amendment No. 2 (the "Amendment") to the joint filing on Schedule 13G by Thomas W. Smith, Scott J. Vassalluzzo and Steven M. Fischer originally filed with the Securities and Exchange Commission on April 8, 2011, as amended by Amendment No. 1 filed by Prescott General Partners LLC ("PGP"), Thomas W. Smith and Scott J. Vassalluzzo with the SEC on January 1, 2012 (as amended, the "Schedule 13G"). Unless otherwise indicated, all capitalized terms used herein shall have the meanings given to them in the Schedule 13G.

(a) PGP – 3,890,677 shares; Thomas W. Smith – 1,612,188 shares; Scott J. Vassalluzzo – 197,088 shares.

(b) PGP – 6.2%; Thomas W. Smith – 2.6%; Scott J. Vassalluzzo – 0.3%.

PGP, as the general partner of the Partnerships, may be deemed to share the power to vote or to direct the vote and to dispose or to direct the disposition of 3,890,677 shares held by the Partnerships. Mr. Smith has the sole power to vote or to direct the vote of and to dispose or to direct the disposition of 1,310,000 shares. Mr. Vassalluzzo has the sole power to vote or to direct the vote of and to dispose or to direct the disposition of no shares. In their capacities (c) as investment managers for certain managed accounts, Messrs. Smith and Vassalluzzo may be deemed to have the shared power to vote or to direct the vote of and to dispose or to direct the disposition of 302,188 and 197,088 shares, respectively. Voting and investment authority over investment accounts established for the benefit of certain family members and friends of Mr. Smith is subject to each beneficiary's right, if so provided, to terminate or otherwise direct the disposition of the investment account.

ITEM 5. Ownership of Five Percent or Less of a Class

ITEM 6. Ownership of More than Five Percent on Behalf of Another Person

PGP, as the general partner of the Partnerships, may be deemed to beneficially own 3,890,677 shares held by the Partnerships. Messrs. Smith and Vassalluzzo in the aggregate beneficially own 367,688 shares in their capacities as investment managers for certain managed accounts. The Partnerships and the managed accounts have the right to receive dividends from, and the proceeds from the sale of, the shares held by the Partnerships and the managed accounts, respectively. Voting and investment authority over managed accounts established for the benefit of certain family members and friends of Mr. Smith is subject to each beneficiary's right, if so provided, to terminate or otherwise direct the disposition of the managed account.
