The effective date of the Acquisition was November 2, 2018. The closing price on the trading day prior to the effective date of the Acquisition was \$183.75 for CME Group Class A common stock. Immediately prior to the effective date of the Acquisition and the exchange of shares, Mr. Spencer held 68,033,572 shares of NEX.
