Explanation of Responses:

- (1) The shares are owned by Mathiatis LLC, a limited liability company. The reporting person owns all of the membership interests in Mathiatis LLC and serves as its sole managing member.
 - (2) The stock option became exercisable in three equal annual installments with the first installment being exercisable on February 23, 2007 and the second and third installments being exercisable on February 23, 2008 and February 23, 2009.
On June 9, 2011, 132,447 stock options were distributed from a GRAT. Such options were previously reported as indirectly beneficially held by a GRAT. Following such distribution, the reporting person owns 132,447 stock options directly and 317,553 stock options indirectly by the GRAT.
 - (3) The amount of common shares includes common shares acquired in connection with a 3-for-1 share split effectuated on May 11, 2011.
 - (4) Represents a weighted average sales price; the sales prices range from \$33.85 to \$33.9501. Upon request, the full sale information regarding the number of shares sold at each price increment will be provided to the Commission or to a security holder of the issuer.
 - (5) The shares were sold in order to satisfy state and federal income tax obligations.
