Each Deferred Stock Unit was equivalent in value to one share of NRG Energy, Inc.'s Common Stock, par value \$.01 per share. On June 1, 2016, Mr. Weidemeyer received from NRG Energy, Inc. one such share of Common Stock in exchange for each Deferred Stock Unit he was issued on that same date.
- (2) Mr. Weidemeyer sold 3,182 shares to cover his tax obligations following the annual award and conversion of Deferred Stock Units on June 1, 2016.
