The sale reported in this Form 4 was effected pursuant to a pre-planned trading plan entered into in accordance with Rule 10b5-1 of the Securities Exchange Act of 1934 and previously referenced in a MasterCard Incorporated Form 8-K filed on November 23, 2007. The pre-planned trading plan was adopted by the reporting person on November 19, 2007.

This Form 4 contains 30 of 152 price increments relating to a transaction that was executed on February 6, 2008. This is the first of six Form 4s relating to such transaction. Five additional Form 4s containing the balance of the price increments are being filed simultaneously.
