The award of the stock options was previously reported by the reporting person on a Form 4 filed on April 5, 2010.
  - (2) The awarded stock options vest as follows: (1) one-third of the award (100,000 shares) will vest on April 1, 2011, (2) one-third of the award (100,000 shares) will vest on April 1, 2012, and (3) one-third of the award (100,000 shares) will vest on April 1, 2013.
