On May 30, 2008, Mr. Mao cancelled his previously-granted 1.5 million shares of restricted stock and the Compensation Committee of the Board approved a new grant of restricted stock units, or RSUs, for 1.5 million shares, to be granted effective June 3, 2008. The

- (1) restricted shares were originally granted in connection with Mr. Mao's hiring as the Company's new Chief Executive Officer. This follows an agreement between Mr. Mao and the Company that his initial hiring stock grant should take the form of restricted stock units, rather than shares of restricted stock. This was done for administrative purposes.
