- (3) Held by the issuer to implement restrictions on transfer unless and until certain conditions are met.
- (4) Shares represented by ArvinMeritor stock fund units under the Rockwell Automation Savings Plans, based on information furnished by the Plan Administrator. The shares represented by ArvinMeritor stock fund units are held in an employee benefit trust established thereunder.
- (5) Period acquisitions of share equivalents related to ArvinMeritor common stock, held under the ArvinMeritor supplemental savings plan, based on information furnished by the Plan Administrator as of October 31, 2002.
- (6) Options will become exercisable in whole or in part (but only for a whole number of shares) as to one-third of the option shares beginning on November 22, 2003, as to an additional one-third of the option shares beginning on November 22, 2004, and as to the balance of the option shares beginning on November 22, 2005.
