Unilever NV announces that on 14 May 2007 it purchased 500,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at a price of euro 23.276 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 173,019 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 65,193,699 Unilever NV ordinary shares in treasury, and has 1,649,534,001 Unilever NV ordinary shares in issue (excluding treasury shares).
