Unilever NV announces that on 16 October 2007 it purchased 500,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 21.810 and euro 22.000 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 2,232 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 100,324,850 Unilever NV ordinary shares in treasury, and has 1,614,402,850 Unilever NV ordinary shares in issue (excluding treasury shares).
