On May 2, 2005, DIMON Incorporated issued a press release announcing that, as part of its previously announced (1) cash tender offer for any and all of its outstanding (a) 9⁵/₈% Senior Notes due 2011 (the 9⁵/₈% Notes) and (b) 7¹/₄% Senior Notes due 2013 (the 7¹/₄% Notes and, collectively with the 9⁵/₈% Notes, the Notes), and (2) solicitation of consents to amend each of the indentures governing the Notes, it is extending the expiration date of the tender offer.
