ChipMOS REPORTS FEBRUARY 2008 REVENUES

Hsinchu, Taiwan, March 17, 2008 ChipMOS TECHNOLOGIES (Bermuda) LTD. (ChipMOS or the Company) (NASDAQ: IMOS) today reported its unaudited consolidated revenues for the month of February 2008.

Revenues for the month of February 2008 was NT\$1,482.6 million or US\$47.9 million, a decrease of 11.8% from the month of January 2008 and a decrease of 15.9% from the same period in 2007. (All translations from NT dollars to U.S. dollars were made at the exchange rate of NT\$30.93 against US\$1.00 as of February 29, 2008.)
