(a)-(b) Mr. Buffett owns, and has the sole power to vote and to dispose of, 350,000 shares of Class A Common Stock and 1,501,532 shares of Class B Common Stock, representing approximately 33.10% of the outstanding shares of Class A Common Stock, 10.12% of the outstanding shares of Class B Common Stock, 31.60% of the aggregate voting power of the outstanding shares of both classes, and 25.78% of the economic interest of the outstanding shares of both classes.

On July 1, 2009, Mr. Buffett donated 428,688 shares of Class B Common Stock to the Bill and Melinda Gates Foundation pursuant to his previously announced irrevocable pledge to this foundation.

On July 1, 2009, Mr. Buffett donated 42,869 shares of Class B Common Stock to the Susan Thompson Buffett Foundation pursuant to his previously announced irrevocable pledge to this foundation.

On July 1, 2009, Mr. Buffett donated 15,005 shares of Class B Common Stock to each of the Sherwood Foundation, the Howard G. Buffett Foundation and the NoVo Foundation pursuant to his previously announced irrevocable pledges to these foundations.
