This prospectus supplement no. 3 supplements our prospectus dated October 29, 2009, as supplemented by the prospectus supplement no. 1 dated November 13, 2009 and prospectus supplement no. 2 dated November 20, 2009 (the prospectus), relating to the resale from time to time by certain selling securityholders of up to (i) 1,400,000 shares of our 7.50% Series B Cumulative Perpetual Convertible Preferred Stock, par value \$0.01 per share and with a liquidation preference of \$100 per share, which we refer to as the preferred stock, and (ii) 19,858,160 shares of our common stock, par value \$0.01 per share, issuable upon conversion of the preferred stock.

You should read this prospectus supplement no. 3 in conjunction with the prospectus, as previously supplemented. This prospectus supplement no. 3 is qualified by reference to the prospectus, except to the extent that the information in this prospectus supplement no. 3 supersedes the information contained in the prospectus, as previously supplemented.
