USFDA lifts import alert from Dr. Reddy s Chemical Manufacturing Facility at Cuernavaca, Mexico

Hyderabad, India, July 27, 2012: Dr. Reddy s Laboratories Ltd. (NYSE: RDY) today announced that the import alert at Quimicas Falcon de Mexico SA de C.V. (Dr. Reddy s chemical manufacturing facility at Cuernavaca, Mexico), a wholly owned subsidiary of Dr. Reddy s Laboratories Limited has been lifted. Dr. Reddy s received a clearance from the United States Food and Drug Administration (USFDA) on 26 July, 2012.

Dr. Reddy s Mexico facility was inspected by USFDA in November 2010. Based on observations by the USFDA, a Warning Letter was shared on June 14, 2011 with the company.

Dr. Reddy s worked with USFDA to resolve the observations in the Warning Letter. An inspection report after the last inspection from 26-30 March, 2012 indicated that they are satisfied with all the outstanding action points that Dr. Reddy s has submitted.

With the satisfactory closure of observations in the warning Letter and the lifting of the import alert, Dr. Reddy s can now start importing products to the US from this facility.

The Mexico facility produces Intermediates and Active Pharmaceutical Ingredients.
