The 2013 Annual Meeting of Stockholders of Sirius XM Radio Inc. (the Company) will be held at the Auditorium at The AXA Equitable Center, 787 Seventh Avenue, New York, New York, on Tuesday, May 21, 2013, at 9:00 A.M. (local time).

Proposals to be considered at the Annual Meeting:

(1) Election of thirteen Directors to serve until the 2014 annual meeting of stockholders of the Company;

(2) Ratification of the appointment of KPMG LLP as our independent registered public accountants for 2013; and

(3) A stockholder proposal regarding the adoption of a succession planning policy.

**Sirius XM's Board of Directors recommends a vote FOR each director nominee under Proposal 1, FOR Proposal 2, and AGAINST Proposal 3.**
