On November 19, 2013, Onyx Pharmaceuticals, Inc. (<u>Ony</u>x), a subsidiary of Amgen Inc., is issuing a notice of redemption to holders of Onyx soutstanding 4.00% Convertible Senior Notes due 2016 (CUSIP Number 683399AB5) (the <u>Notes</u>) announcing its intention to redeem all outstanding Notes in full on December 24, 2013 in accordance with the terms of the indenture governing the Notes, at a redemption price of \$1,115.99 per \$1,000 principal amount of Notes redeemed (which includes a make-whole premium of \$101.66 per \$1,000 principal amount of Notes). The remaining outstanding aggregate principal amount of the Notes as of November 15, 2013 was \$35,000.00.
