Item 1.01 Entry Into Material Definitive Agreements.

On March 27, 2015, we entered into a sixth amendment to extend closing under our May 28, 2014 agreement to sell Nashville Superspeedway. Closing is now scheduled to take place on or before May 27, 2015. The purchaser made a non-refundable \$400,000 payment for the extension. Depending on when closing occurs, a prorated amount of this payment will be applied against the purchase price under the agreement.
