### **Explanatory Note**

Pursuant to General Instruction E to Form S-8, Lamar Advertising Company (the Company ) incorporates by reference into this Registration Statement the contents of its registration statements filed on Form S-8 on August 13, 2013 (File No. 333-190604), June 27, 2012 (File No. 333-182365), and July 31, 2009 (File No. 333-160943), each as amended on November 19, 2014, relating to its 2009 Employee Stock Purchase Plan (the Plan ), except as expressly modified herein.

The number of shares of Class A Common Stock of the Company available for delivery under the Plan is subject to an automatic annual increase on the first day of each fiscal year of the Company equal to the least of (i) 500,000 shares, (ii) one-tenth of one percent of the total number of shares of Class A Common Stock outstanding on the last day of the preceding fiscal year, and (iii) a lesser amount determined by the Board of Directors. This Registration Statement registers the 80,933 additional shares of Class A Common Stock resulting from the automatic annual increase for fiscal year 2015 and the 80,209 additional shares of Class A Common Stock resulting from the automatic annual increase for fiscal year 2014.
