LLC, UBS Securities LLC and Wells Fargo Securities, LLC, as Representatives of the underwriters named in the Underwriting Agreement, for the sale of \$800,000,000 aggregate principal amount of the Company s 2016 Series A 5.25% Enhanced Junior Subordinated Notes due 2076. The 2016 Series A 5.25% Enhanced Junior Subordinated Notes that were registered by the Company pursuant to a registration statement on Form S-3 under Rule 415 under the Securities Act of 1933, as amended, which registration statement became effective on December 19, 2014 (File No. 333-201149).
