As of December 31, 2018, Mr. Steers beneficially owned 11,975,471 shares of common stock, which includes 65,163 shares of common stock underlying restricted stock units that vested on January 31, 2019, of which 34,641 shares were delivered and 30,522 shares were withheld by the issuer to satisfy the reporting person's tax withholding obligations; 950,920 shares held by the Robert H. Steers Family Trust, of which a member of Mr. Steers' immediate family serves as trustee of the trust; 4,218,897 shares held by the Steers 2014 Descendants' Trust, of which members of Mr. Steers' immediate family serve as trustees of the trust; and 6,740,491 shares held by the Robert H. Steers 2018 Revocable Trust, of which Mr. Steers and a member of his immediate family serve as trustees of the trust. Mr. Steers disclaims beneficial ownership of the shares held by the Robert H. Steers Family Trust and the Steers 2014 Descendants' Trust.
