Item 4. Ownership

(a) Amount Beneficially Owned (describe): Of the 3,281,959 shares reported pursuant to this Schedule 13G; 165,864 shares are held by Mr. Dunkel's 2005 Grantor Retained Annuity Trust; 1,200,000 shares are held by Mr. Dunkel's 2006 Grantor Retained Annuity Trust; 324,555 shares are held by the Dunkel Family Receptacle Trust; 1,590 shares are held in custody for Mr. Dunkel's children; 1,418,048 shares are subject to options exercisable within 60 days of December 31, 2006; and 171,903 shares are held directly by Mr. Dunkel's Revocable Trust.

(b) Percent of Class: 8 %, based on the 40,848,696 outstanding shares reported on the most recently filed Form 10-Q for the quarter ending September 30, 2006, along with Mr. Dunkel's options exercisable within 60 days of December 31, 2006.

(c) Number of shares as to which such person has:

- (ii) Shared power to vote or to direct the vote: 324,555
- (iii) Sole power to dispose or to direct the disposition of: 2,957,404
