ESP is the record holder of the Common Units of the Issuer ("Units") reported in this line on this Form 4 and has a direct pecuniary interest in the Units. ESSC, ESLLC, and ESCLP beneficially own the Units for the purposes of Section 13(d) of the Exchange Act and have an indirect pecuniary interest in the Units.
- (1) On August 15, 2016, ESP sold 213,881 Units on the New York Stock Exchange in open market sales, at prices ranging from \$12.00 to \$12.25 per Unit, with a weighted-average per-Unit price of \$12.1635.
 - (2) On August 16, 2016, ESP sold 192,332 Units on the New York Stock Exchange in open market sales, at prices ranging from \$12.14 to \$12.18 per Unit, with a weighted-average per-Unit price of \$12.1496.
