- (1) The sales reported in this Form 4 were effected pursuant to a Rule 10b5-1 trading plan.
- (2) Represents the weighted average price of shares sold at prices that ranged from \$20.56 to \$21.13.
- (3) The option becomes exercisable beginning 09/24/02 and 1/48 per month thereafter over four years.
