 - (1) Consists of restricted stock units (RSUs) granted for serving on one or more Committees of the Board. The RSUs will be converted into shares of Sara Lee common stock on a one-for-one basis on the date six months after the reporting person ceases to be a director of Sara Lee.
 - (2) Includes 14,660 RSUs that may be settled only for shares of common stock. RSUs vest one year after the grant date and, on the settlement date, are convertible into shares of common stock on a one-for-one basis. The settlement date is either three years after the date of grant, for RSUs granted before July 2005, or six months after the reporting person ceases to be a director of Sara Lee, for other RSUs.
 - (3) On September 5, 2006, Sara Lee Corporation distributed, as a pro rata stock dividend, all of the shares of its wholly-owned subsidiary, Hanesbrands Inc., to holders of record of Sara Lee common stock as of the close of business on August 18, 2006 (the "spin off"). Effective upon completion of the spin off, the Compensation and Employee Benefits Committee of Sara Lee's Board of Directors adjusted all outstanding Sara Lee restricted stock units to preserve the pre-spin off intrinsic value of such RSUs. As a result, on September 6, 2006, 12,543 RSUs held by the reporting person immediately prior to the spin off were adjusted to equal 14,568 RSUs.
