- (1) 339 previously owned shares having a market value of \$35.11 per share were delivered in payment of the option price of \$7.94 per share for 1,500 shares acquired pursuant to the exercise of an option granted under the 2002 Plan. In addition, 374 shares were withheld to pay Federal withholding taxes as permitted by the 2002 Plan and option grant.
- (2) 1,500 shares were acquired pursuant to the exercise of an option granted under the 2002 Plan.
