(1) The option is exercisable in five equal annual installments beginning on January 10, 2009.

Options were granted by Marine Bancorp. Upon merger with Home BancShares on 6/1/05, these options became 100% vested. However, prior to the merger, 645 options were vested with an expiration date of 12/31/2009 and 251 options were vested with an expiration date of 3/31/2011. The remaining 52 options were vested on 6/1/05 with an expiration of 3/31/2011. Upon conversion, 1,935 options have an expiration of 12/31/2009 and 909 options have an expiration of 3/31/2011.
