(1) Loews Corporation ("Loews") owns 100% of the common stock of Lorillard, Inc. ("Lorillard"). As described in Registration Statement No. 333-149051, on June 10, 2008, Loews intends to distribute 108,478,429 shares of Lorillard common stock in redemption of and in exchange for a like number of shares of Carolina Group stock, a class of common stock of Loews. On or about the June 16, 2008, Loews intends to distribute up to 65,445,000 shares of Lorillard common stock that it will own at such time in exchange for up to 93,492,857 shares of Loews common stock that are validly tendered to Loews pursuant to an exchange offer made by Loews on May 9, 2008, as described in Registration Statement No. 333-149051.
