- (1) The reported transaction involves an award of restricted stock units under the M&T Bank Corporation 2005 Incentive Compensation Plan. Each restricted stock unit represents a contingent right to receive one share of M&T Bank Corporation common stock upon vesting. The restricted stock unit award includes a total of 10,024 shares. 1,002 shares of the restricted stock unit award will vest on January 30, 2010; an additional 2,005 shares will vest on January 30, 2011; an additional 3,007 shares will vest on January 30, 2012; and the remaining 4,010 shares will vest on January 30, 2013.
  - (3) The restricted stock units were granted under an incentive compensation plan maintained by M&T Bank Corporation, and therefore the reporting person paid no price for the restricted stock units.
  - (4) Jointly owned.
  - (5) The information presented is as of January 5, 2009.
