(1) The reporting person exchanged 11,618 shares of Class A Common Stock, par value \$0.01 per share, for 11,618 shares of Series A Preferred Stock, par value \$0.01 per share, in an issuer exchange offer.

(2) Of the 76,333 shares beneficially owned, (a) 3,999 shares are unvested restricted shares that the reporting person was granted on 11/16/06 which vest on 11/16/09; (b) 23,734 shares are unvested restricted shares that the reporting person was granted on 12/10/07, of which 11,867 vest on each of 1/2/10 and 1/2/11; and (c) 48,600 shares are unvested restricted shares that the reporting person was granted on 12/8/08 which vest in substantially equal installments on 1/10/10, 1/10/11 and 1/10/12.
