- (1) The reporting person was granted 4,522 shares of Common Stock, issued pursuant to the 2007 RPM International Inc. Restricted Stock Plan.
- (2) The reporting person was granted 25,000 shares of Common Stock, issued as Performance Earned Restricted Stock, pursuant to the RPM International Inc. 2004 Omnibus Equity and Incentive Plan.
- (3) On July 19, 2010, 24,000 shares of Common Stock, issued as Performance Contingent Restricted Stock, were forfeited by the reporting person and disposed back to the issuer.
