The number of share equivalents shown is an estimate because the Reporting Person's interest in the Plan is denominated in units.
- Represents a payout of phantom stock units under the Plan pursuant to an election made by the Reporting Person in 2008. Each phantom stock unit represents a hypothetical investment in Hanesbrands Inc. common stock under the Plan.
