On June 30, 2011, the date immediately preceding the effective date of the Merger, the closing price of Frontier's common stock was \$32.31 per share and the closing price of Holly Corporation's common stock was \$69.40.
 - (2) These shares were deemed surrendered to satisfy the reporting person's tax liability incident to the issuance of HollyFrontier's common stock for the settlement of the 39,933 performance stock units of Frontier described in the preceding footnote.
