- Grant of restricted share units ("RSUs") pursuant to the Avago Technologies Limited 2009 Equity Incentive Award Plan, (the "Plan").
- (1) Upon vesting thereof, the Reporting Person is entitled to receive one (1) ordinary shares for each one (1) RSU. The RSUs vest as to 50% on the seventh business day of the second fiscal month of Avago's second fiscal quarter in each of fiscal years, 2015 and 2016, subject to the Reporting Person's continuing service on the vesting date.
  - (2) Shares held by Douglas R. Bettinger as Trustee for the Bettinger Family Trust, dated June 6, 2007
  - (3) Employee option to purchase ordinary shares granted pursuant to the Avago Technologies Limited 2009 Equity Incentive Award Plan. The option vests as to 50% of the shares subject thereto on each of March 6, 2015 and March 6, 2016.
