Pursuant to the Employee Matters Agreement, by and between Edgewell Personal Care Company ("Edgewell") and Energizer Holdings, Inc. ("Energizer"), dated as of June 25, 2015, to reflect the separation of Energizer from Edgewell by means of a pro rata distribution of

(1) 100% of the outstanding shares of Energizer common stock to Edgewell stockholders of record on June 16, 2015, each outstanding restricted stock equivalent award ("RSE") owned by the Reporting Person was adjusted on July 8, 2015 to maintain the intrinsic value of the award.

(2) Fifty percent of the RSE will vest and convert into shares of Edgewell Common Stock on 01/05/2016 and the remaining fifty percent will vest and convert into shares of Edgewell Common Stock on 01/05/2017, in each case if Reporting Person is employed on said date. All or a portion may vest upon death, disability, change of control or certain termination events.

(3) One-third of the RSE granted will vest and convert into shares of Edgewell Common Stock on each of 07/08/2016, 07/08/2017 and 07/08/2018 if Reporting Person is employed on said dates or all or a portion may vest upon death, disability, change of control or certain
