- (2) On September 21, 2015, the Compensation Committee of the Board of Directors of the Issuer determined that the performance conditions were met with respect to 451,931 of the 575,580 Performance Share Units granted to Mr. Luczo on September 10, 2012. Achievement of performance objectives resulted in the Reporting Person earning Ordinary Shares in the amount of 157% of the Performance Share Units granted. The 451,931 Ordinary Shares vested on September 21, 2015.
- (3) On September 21, 2015, Mr. Luczo transferred 36,797 Ordinary Shares previously owned directly to the Stephen J. Luczo Revocable Trust dated January 26, 2001.
