- (1) The Ordinary Shares may be represented by American Depositary Shares, each of which represents one Ordinary Share.  
As previously reported on July 8, 2015, the Reporting Person was granted 600,000 Restricted Stock Units ("RSUs") under the Amarin Corporation plc 2011 Stock Incentive Plan (the "Plan"). These RSUs vest in 16 equal quarterly installments. The eighth vesting event occurred on June 30, 2017.

- (7) On February 1, 2017, the Reporting Person was granted 359,000 RSUs under the Plan. These RSUs were subject to the approval by the Company's shareholders of an amendment to the Plan, which amendment was approved on May 15, 2017, and were previously disclosed in the Company's definitive proxy statement on Schedule 14A filed with the Securities and Exchange Commission on April 21, 2017. These RSUs vest in three equal installments on each of January 31, 2018, January 31, 2019 and January 31, 2020.

As of the date of this Form 4, the Reporting Person owns or holds the right to acquire an aggregate of 9,593,576 Ordinary Shares.
