- Each restricted stock unit represented a contingent right to receive one share of Emcore common stock. Restricted stock units were
- (1) payable, at the election of the Issuer, in cash, Emcore common stock, or a combination of the two. On January 30, 2013, the Issuer settled the restricted stock units in common stock.
  - (2) Includes 12,500 shares of restricted stock granted under the Company's 2010 Equity Incentive Plan, vesting on January 28, 2014.
- All sales were effected pursuant to a 10b5-1 plan previously adopted by the Reporting Person to satisfy the Reporting Person's tax
