The shares of phantom stock become payable, in cash or common stock, at the election of the Reporting Person, upon the earlier to occur on the tenth (10th) business day following (i) the Reporting Person's separation from service as a director or (ii) a Change of Control (as defined under the Issuer's Directors Deferred Compensation Plan).
