(1) The Reporting Person was granted 41,141 shares of Restricted Common Stock under the 2006 Stock-Based Incentive Compensation Plan. 13,250 shares vest over a three year period as follows: 4,417 shares on February 28, 2014 and February 28, 2015, respectively, and 4,416 shares on February 28, 2016. The final 27,891 shares vest on February 28, 2016 based on the Company's Total Shareholder Return versus a defined peer group of companies, with the final number of performance based vested shares varying from 0 to 200% of 27,891.
