- (1) The Reporting Person was granted 13,607 shares of Restricted Common Stock under the 2013 Stock-Based Incentive Compensation Plan. 4,800 shares vest over a three year period as follows: 1,600 shares on January 3, 2015, January 3, 2016 and January 3, 2017, respectively. The final 8,807 shares vest on January 3, 2017 based on the Company's Total Shareholder Return versus a defined peer group of companies, with the final number of performance based vested shares varying from 0 to 200% of 8,807.
