Robert J. Susor, age 65, will retire from his position as Executive Vice President effective April 30, 2011. Mr. Susor has been an Executive Vice President of the Company since 2003 and previously served as Senior Vice President-Market Development from 1991 to 2003.

On February 21, 2011, the Board of Directors of Genuine Parts Company announced the election of Mr. John R. Holder as a new Director of the Company. Mr. Holder is Chairman and Chief Executive Officer of Holder Properties in Atlanta, Georgia, and has held these positions since 1989 and 1980, respectively. Item 8.01 Other Events.

On February 21, 2011, the Board of Directors of Genuine Parts Company declared an increase of 10% in the regular quarterly cash dividend for 2011. The Board increased the cash dividend payable to an annual rate of \$1.80 per share compared with the previous dividend of \$1.64 per share. The quarterly cash dividend of forty-five cents (\$.45) per share is payable April 1, 2011 to shareholders of record March 11, 2011.
