(3) The amount of securities beneficially owned following the reported transactions includes shares of common stock acquired under the ONEOK, Inc. Employee Stock Purchase Plan and the ONEOK, Inc. Thrift Plan which acquisitions are exempt under Rule 16a-11.

The award vests on January 20, 2008, and is payable one-third in cash and two-thirds in shares of the Issuer's common stock based on FMV of one share of Issuer's common stock on date of vesting. The amount set forth in Column 5 represents the two-thirds portion of the grant payable in shares of the Issuer's common stock.
