In the discretion of the Compensation Committee, upon vesting the value of the RSU grant alternatively may be paid in cash, or partly in common shares.
- (2) The reporting person is CEO of Haverford Investment Management (GP), Limited and disclaims beneficial ownership of these shares.
- (3) The RSUs vest 100% on the date of grant and do not have an expiration date.
