- On December 31, 2013, 66,667 restricted stock units held by Mr. Morhaime vested. Pursuant to the terms of his restricted stock unit

- (2) Following the receipt thereof, Mr. Morhaime transferred the net shares he received in connection with the vesting of his restricted stock units to the Michael Morhaime Revocable Trust.
- (3) Following the transactions reported on this Form 4, Mr. Morhaime directly held 339,998 restricted stock units, each representing the right to receive one share of the Company's common stock.
- (4) Following the transactions reported on this Form 4, Mr. Morhaime indirectly held (through the Michael Morhaime Revocable Trust) 173,767 shares of the Company's common stock.
- (5) These securities are held by the Michael Morhaime Revocable Trust.
